

## Tax Policy and the Immigrant Experience

Amanda Bartmann is an attorney adviser to the national taxpayer advocate at the Taxpayer Advocate Service (TAS), an independent organization within the Internal Revenue Service. Bartmann has been involved in all aspects of TAS's work on creating and implementing the Taxpayer Bill of Rights, and she recently published an article in the *Tax Lawyer* on integrating taxpayer rights into a tax agency's operations. Bartmann also focuses on tax issues related to immigration and international individuals. In 2012, Bartmann was detailed to the Senate Finance Committee staff. While in law school, she was a student attorney in the Janet R. Spragens Federal Tax Law Clinic. Bartmann received a BA in English from the University of Maryland and a JD from the Washington College of Law at American University.

Cara Cardotti is the program director for the metroCASH Volunteer Income Tax Assistance (VITA) program at the United Way of Greater Richmond and Petersburg, which provides free tax preparation services to low- and moderate-income working taxpayers within the region where she oversees 14 tax sites. Cardotti is also the THRIVE Collaborative manager at the United Way of Greater Richmond and Petersburg, where she staffs the THRIVE Service Provider Network. From 2005 to 2013, Cardotti was a case worker with the Hanover Department of Social Services, where she worked with participants of a federally funded employment program, providing supportive services to move them toward self-sufficiency. Cardotti has been involved with VITA since 2005 as a site coordinator and a volunteer.

**Howard Gleckman** is a senior fellow in the Urban-Brookings Tax Policy Center at the Urban Institute, where he edits the fiscal policy blog *TaxVox* and the daily news summary the *Daily Deduction*. He is also affiliated with Urban's Program on Retirement Policy, where he works on long-term care issues. Before joining Urban, Gleckman was senior correspondent in the Washington bureau of *Business Week*, where he was a 2003 National Magazine Award finalist. He was a 2006–07 media fellow at the Kaiser Family Foundation and a visiting fellow at the Center for Retirement Research at Boston College from 2006 to 2008. Gleckman writes two regular columns for *Forbes* on tax policy and elder care. He is author of the book *Caring for Our Parents* and speaks and writes frequently on long-term care issues.

Mark J. Mazur is the Robert C. Pozen director of the Urban-Brookings Tax Policy Center. His research interests cover all aspects of tax policy. From 2012 until early 2017, he was the assistant secretary for tax policy at the US Department of the Treasury. Mazur served in the federal government for 27 years in various positions, including policy economist at the congressional Joint Committee on Taxation, senior economist at the President's Council of Economic Advisers; senior director at the National Economic Council; chief economist and senior policy adviser and director of policy at the US Department of Energy; acting administrator of the Energy Information Administration; director of research, analysis, and statistics at the Internal Revenue Service; and deputy assistant secretary for tax analysis in the Office of Tax Policy. Before entering public service, Mazur was an assistant professor in Heinz College at Carnegie-Mellon University. He has a bachelor's degree in financial administration from Michigan State University and a master's degree in economics and doctorate degree in business from Stanford University.



Kim Rueben, a senior fellow in the Urban-Brookings Tax Policy Center at the Urban Institute, is an expert on state and local public finance and the economics of education. Her research examines state and local tax policy, fiscal institutions, state and local budgets, education finance, and public-sector labor markets. Rueben directs Urban's State and Local Finance Initiative. Her current projects include work on state budget shortfalls, financing options for California, cities' fiscal health, and higher education tax credits and grants. She served on a council of economic advisers for the controller of the State of California and a National Academy of Sciences panel on the economic and fiscal consequences of immigration, and she was on the DC Tax Revision Commission in 2013. In addition to her position at Urban, Rueben is an adjunct fellow at the Public Policy Institute of California, where she was previously a research fellow. She has been an adjunct professor at the McCourt School of Public Policy at Georgetown University and the Goldman School of Public Policy at the University of California, Berkeley; a visiting scholar at the San Francisco Federal Reserve Bank; and a member of the executive board of the American Education Finance Association. Rueben received a BS in applied math-economics from Brown University, an MS in economics from the London School of Economics, and a PhD in economics from the Massachusetts Institute of Technology.

**Sam Solomon** is deputy director of policy for the New York City Mayor's Office of Immigrant Affairs, where he has been a cochair of the Mayor's Task Force on Immigrant Health Care Access and worked on such programs as the city's municipal identification card IDNYC, immigration legal services programs, and more. Solomon formerly was a journalist specializing in health policy. He is an attorney and a member of the New York state bar.

Jackie Vimo is a policy analyst, scholar, and organizer based in Brooklyn and Washington, DC. She is a policy analyst for the National Immigration Law Center (NILC), a national organization that engages in policy analysis, litigation, education, and advocacy to defend and advance the rights and opportunities of low-income immigrants and their families. Vimo has worked for almost two decades on public policy issues in California, New York, and Argentina. Before working at the NILC, Vimo was director of advocacy at the New York Immigration Coalition, a statewide umbrella organization for organizations working with immigrants in New York State. Vimo has taught in the political science department of the City College of New York and the New School and is a PhD candidate in politics at the New School, writing a dissertation on state-level immigrant rights movements in the United States since 1994.
