The breaks are (in 2020 dollars): 20% \$27,700; 40% \$54,700; 60% \$98,600; 80% \$181,700; 90% \$264,900; 95% \$384,800; 99% \$893,600; 99.9% \$3,971,900.

<sup>(4)</sup> We calculate each tax unit's effective marginal individual income tax rate by adding \$1,000 to the income source and dividing the resulting tax change by that \$1,000. We then calculate the averages by weighting by the initial value of the appropriate income source.

<sup>(5)</sup> We calculate each tax unit's effective marginal individual plus payroll tax rate by adding \$1,000 to wages and salaries. We then divide the resulting change in individual income tax plus the resulting change in the employer and employee portions of payroll taxes for Social Security and Medicare by that \$1,000. We then calculate the averages by weighting by the initial value of wages and salaries. For married couples filing jointly, we assign a portion of the \$1,000 increase to each spouse based on their initial shares of the household's total wages and salaries.
