[3] Includes taxes, user charges, miscellaneous general revenue, utility revenue, liquor store revenue, and social insurance revenue. Own-source total revenue is calculated by subtracting intergovernmental revenue from total revenue. This figure should not be confused with own-source general revenue.

[4] Includes substantial but unknown amounts of federal grants to states that are "passed through" by the states to local governments.
