(1) Distribution excludes dependents and units with negative income.

(2) Percentiles contain equal numbers of people; they may contain differing numbers of tax units.

(3) Income breaks defining percentiles were determined separately for each filing status, so a tax unit may fall into one percentile for its filing status and a different percentile among all tax units. Furthermore, within each filing status, percentiles contain equal numbers of people.

(4) Counts for married couples filing separately are not shown but are included in counts for all tax units.
