Biographies

Karlyn Bowman is a Senior Fellow at the American Enterprise Institute. She joined the Institute in 1979 and was Managing Editor of *Public Opinion* magazine until 1990. From 1990 to 1995 she was the editor of *The American Enterprise*. Today Bowman is a contributing editor to AEI's magazine, *The American*. In 2002, Bowman inaugurated a series of Public Opinion Studies that are available on AEI's website. They include "Polls on Patriotism," "Attitudes Toward Homosexuality and Gay Marriage," "Public Opinion on Taxes," "Attitudes Toward Social Security Reform," and "Attitudes About Economic Anxiety." Bowman also edits AEI's monthly *Political Report*. She has written regular columns for *Roll Call* and now writes for *Forbes.com*.

Leonard Burman is the Director of the Urban-Brookings Tax Policy Center, a Professor of Public Administration and International Affairs at the Maxwell School of Syracuse University, and senior research associate at Syracuse University's Center for Policy Research. He co-founded the Tax Policy Center, a joint project of the Urban Institute and the Brookings Institution, in 2002. He has held high-level positions in both the executive and legislative branches, serving as Deputy Assistant Secretary for Tax Analysis at the Treasury from 1998 to 2000, and as Senior Analyst at the Congressional Budget Office. He is past-president of the National Tax Association. Burman is the author of *Taxes in America: What Everyone Needs to Know*, with Joel Slemrod, and *The Labyrinth of Capital Gains Tax Policy: A Guide for the Perplexed*, co-editor of *Taxing Capital Income and Using Taxes to Reform Health Insurance*, and author of numerous articles, studies, and reports. Burman's recent research has examined US federal budget dynamics, tax expenditures, financing long-term care, the individual alternative minimum tax, the changing role of taxation in social policy, and tax incentives for savings, retirement, and health insurance.

Christopher Faricy is an Assistant Professor of Political Science and Public Policy at The Maxwell School of Citizenship and Public Affairs at Syracuse University. His research focuses on social policy, tax expenditures, and public opinion. He is the author of the forthcoming book *Welfare vs. Wealthfare: Partisan Politics, the Divided Social System, and Income Inequality in America*. His research project has won a number of national awards including the 2012 Harold D. Lasswell Award, the 2010 Pi Sigma Alpha Award, and the 2009 James Prothro Award. His research has appeared in various journals including multiple times in *The Journal of Politics* and *Political Behavior*. His research project has also been written about in *The Huffington Post*, *Mother Jones*, and *The Monkey Cage* at *The Washington Post*.

William A. Galston holds the Ezra Zilkha Chair in the Brookings Institution's Governance Studies Program, where he serves as a Senior Fellow. He is also College Park Professor at the University of Maryland. Prior to January 2006 he was Saul Stern Professor at the School of Public Policy, University of Maryland, director of the Institute for Philosophy and Public Policy, founding director of the Center for Information and Research on Civic Learning and Engagement (CIRCLE). A participant in six presidential campaigns, he served from 1993 to 1995 as Deputy Assistant to President Clinton for Domestic Policy. A winner of the American Political Science Association's Hubert H. Humphrey Award, he was elected a Fellow of the American Academy of Arts and Sciences in 2004. He writes a weekly column for The Wall Street Journal.

Howard Gleckman is a Resident Fellow at the Urban-Brookings Tax Policy Center. Gleckman is author of *Caring for Our Parents* (St. Martin's Press) and is a frequent writer and speaker on long-term care. He is author of the long-term care chapter in Landmark: *The Inside Story of America's New Health Care Law and What It Means for Us All* (Public Affairs) and of the chapter on long-term care financing in *Universal Coverage of Long-Term Care* (Russell Sage, forthcoming). He writes and edits *TaxVox*, the fiscal policy blog of the Urban-Brookings Tax Policy Center. He was formerly senior correspondent in the Washington bureau of Business Week, where he was a National Magazine Award finalist. He is a member of the Board of Trustees of Suburban Hospital (Bethesda MD) and the Jewish Council for the Aging of Greater Washington.
