Fair, simple, and efficient taxation

Taxes should be simple, fair, and efficient. We recognize and quantify trade-offs among these goals and identify promising reforms.

Business taxation

The taxation of business entities—from single-owner firms to large multinational enterprises—raises complex issues. We analyze the economic effects of proposed business tax reforms and examine alternative approaches.

Social policy in the tax code

Many programs to aid low-income families and promote other social goals are designed as tax subsidies instead of direct expenditures. We evaluate the effectiveness of these policies in achieving their goals as well as their effects on the distribution of tax burdens among households.

Long-term implications of tax and budget choices

The United States faces a dismal fiscal future in part because projected revenues fall far short of anticipated spending needs, especially for health care and retirement benefits. We examine the implications of current policies and proposed tax changes on the well-being of future generations.

State and local fiscal issues

Many Americans pay more in state and local taxes than in federal income taxes, and states promote their own social and economic policy goals through tax policy. TPC experts analyze the interaction of federal, state, and local tax and budget policies and cross-state variation in taxes and evaluate their fairness and efficiency.
